

RULES

This Overnight Campground Permit must be visible in front window of vehicle/aircraft.

This permit allows bearer to pay and camp for one night of camping in designated areas. If additional camping is purchased, camper is required to pay multi-day camping at the time of arrival.

All guests visiting the convention site are also required to purchase a daily registration (wristband), which must be worn visibly to gain access to all areas of the convention site, including all campgrounds.

Only properly permitted vehicles will be allowed access to the convention site. **THIS PERMIT ALLOWS VEHICLES ACCESS TO DESIGNATED CAMPGROUND AREAS ONLY!**

FACILITIES

Water, shower houses, and port-a-potties are available on-site. Please ask directions from your camper host or any registration area.

Tram service is available to transport guests throughout the event grounds.

It is further agreed that the undersigned agrees not to sell, demonstrate, or traffic in any kind of merchandise, or distribute literature, or otherwise carry on any commercial business of any kind, in any campground, at any time at the Lakeland Linder International Airport or SUN 'n FUN grounds.

SUN 'n FUN Fly-In, Inc., reserves the right in its sole and absolute discretion to bar any person or entity that is not in keeping with the character or purpose of SUN 'n FUN, as determined solely and exclusively by SUN 'n FUN, Inc.
