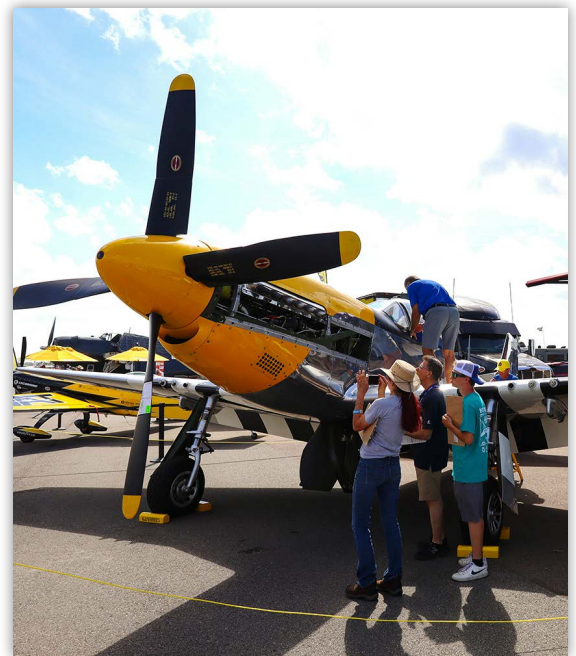
Enjoy access to the Exhibit Office and Oasis located between Hangars B and C.

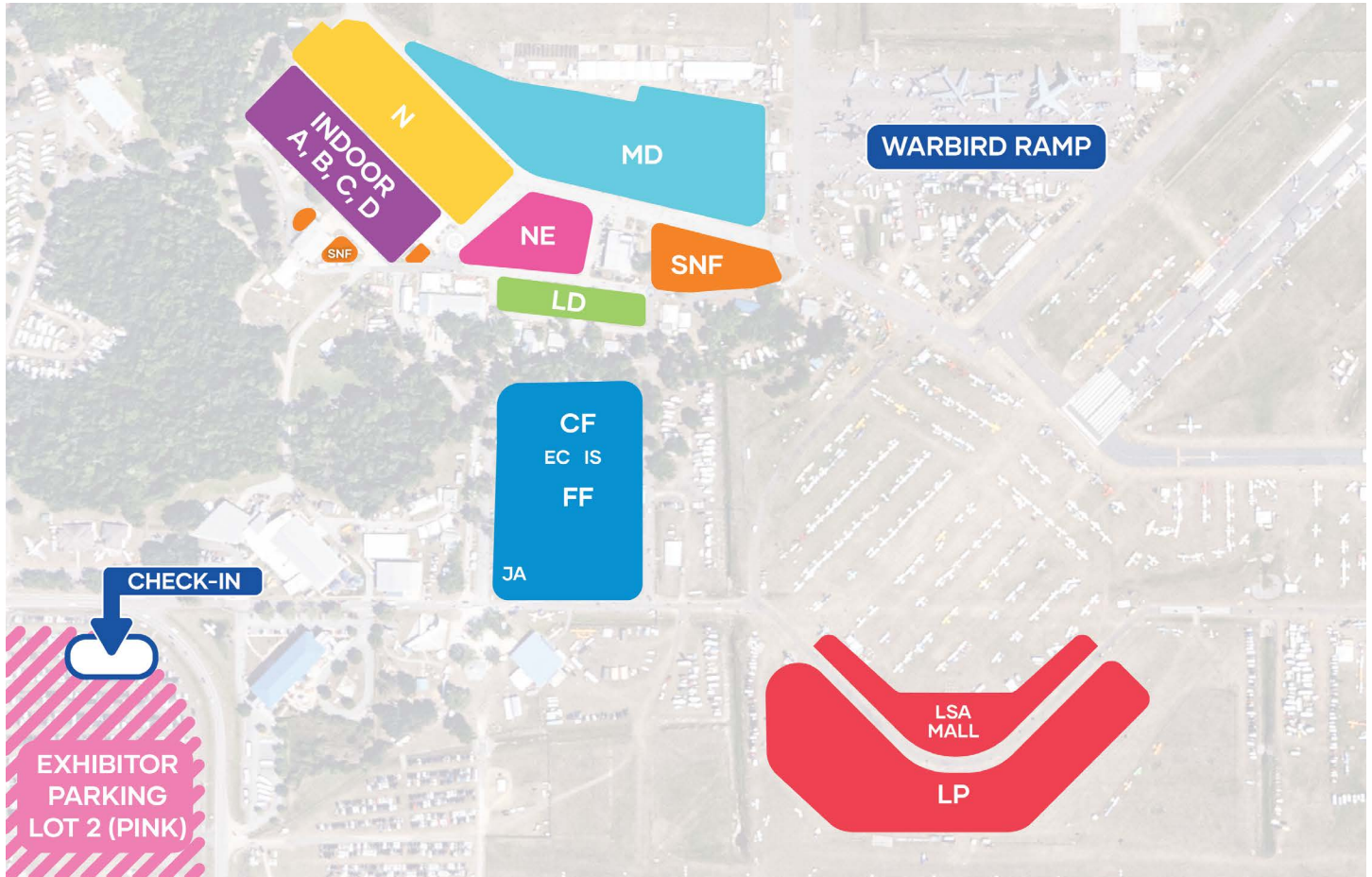
Indoor Exhibits

Four 20,000 sq. ft. hangars at "Show Center" offer 10x10 and 10x20 exhibit spaces including electricity, back and side curtain, pipe & drape, a sign and credentials. Food vendors and restrooms are located within a short walking distance for the convenience of guests and exhibitors alike.

Outdoor Exhibits

Exhibit spaces are available in various sizes and locations. Footprints range from 100 to 10,000 sq. ft. and are priced accordingly. Most spaces include electricity and may have wireless internet capability. Please inquire for details about a specific exhibit space.

Exhibit Spaces Include



Future 'n Flight Plaza (FF)

Large spaces for aircraft and exhibitors requiring a large footprint, just north of the SUN 'n FUN main gate; also the location of the Career Fair, Junior ACEs, Flight Simulation Experience, Innovation Showcase, and Forums.

Career Fair (CF)

Located in a dedicated air-conditioned venue within the Future 'n Flight Plaza. This 6-day expo allows exhibitors to pre-schedule meetings or candidate interviews.

Flight Path Education Center (EC)

Located in a dedicated air-conditioned venue within the Future 'n Flight Plaza. This area is focused on educational programs as well as flight instruction within the aviation and aerospace industry.

Large Display (LD)

Aircraft or other general exhibitors requiring more spaces along Laird Blvd. south of the FAA building.

Light Aircraft, Rotocraft, Homebuilt, Experimental, & EVTOL (LP)

Large spaces just south of vintage & classic aircraft parking along a major tram route. Includes an FAA-approved grass strip with daily flight activity.

Manufacturers Display (MD)

Reserved primarily for aircraft manufacturers, the northern most outdoor exhibit area just south of runway 10/28.

North Exhibits (N)

Exhibitors and small aircraft, just north of the exhibit hangar doors facing runway and airshow box.

North East Exhibits (NE)

Exhibitors and some aircraft, between Hangar A and FAA building.

SUN 'n FUN Exhibits (SNF)

Large spaces primarily for aircraft manufacturers east of the FAA building and south of the Manufacturers Display area.

BREAKDOWN POLICY

Breakdown of exhibit booth/tent prior to 2 pm on Sunday, April 19, 2026 IS PROHIBITED.

We will tug or otherwise assist aircraft in departing the Outdoor Exhibits Areas beginning at 2 pm on Sunday, April 19.

GES will begin positioning trailers in front of Exhibit Hangars A, B, C, and D at 2 pm. Crates will be delivered between 2–6 pm.

Vehicles are permitted access beginning at 6 pm.

Hangars will remain open until 9 pm on Sunday, April 19, and reopen on Monday, April 20 at 8 am (estimated time).

CREDENTIAL POLICY

Access control is an important element of the security program at the SUN 'n FUN Aerospace Expo. Your credential for access to our site is a lanyard and **must be visibly worn at all times**. If you or your team do not have your credentials, you will not be allowed access to the SUN 'n FUN Aerospace Expo Campus.

If you have someone attending who needs lanyards from your allotment, you may leave their name on an envelope at the exhibit/media/sponsor check-in building, thru Tuesday, April 14 for convenient pick-up.

If you need additional credentials (daily/weekly wristband), they may be purchased at either the exhibit check-in or the main registration building.

Will Call Windows 1 & 2 are open from 8am–6pm, daily, Tuesday thru Sunday. No entry to the event will be permitted without an Exhibitor Credential or wristband.

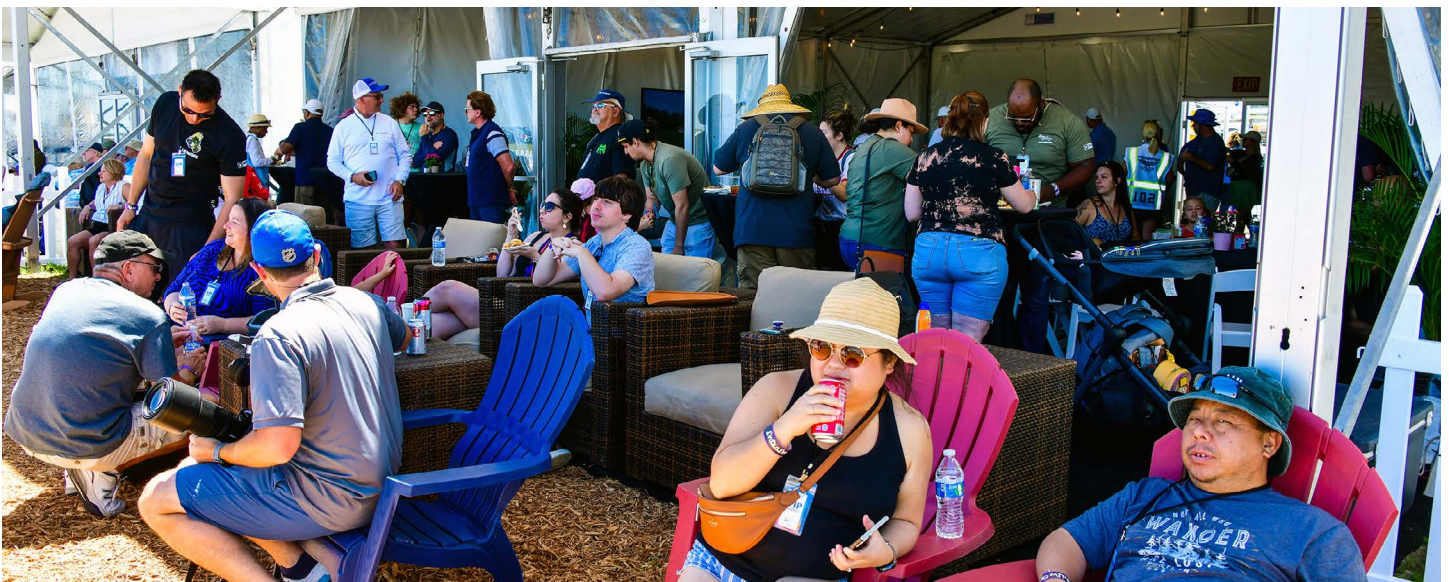

EXHIBITOR OFFICE LOCATION: Check in upon arrival at the Exhibitor Welcome Center, open Sat.- Mon. prior to Expo, located off Medulla Road in the Exhibit Parking Lot. Exhibit Office throughout the Expo is located on the south end of B and C Hangar.

SET UP AND INSTALLATION OF EXHIBITS: Installation of exhibits will be permitted starting Saturday, April 11th and Sunday, April 12th, 2026 from 8:00 a.m. to 5:00 p.m. and Monday, April 13th, 2026 from 8:00 a.m. to 8:00 p.m. No Light Plane landings before Monday April 13th, 2026 in Paradise City.

HOURS OF OPERATION: Shall be from 9 a.m. - 5 p.m., Tuesday-Saturday. Sunday breakdown 2:00 p.m. Indoor Exhibit Hangars will open at 8:00 a.m. Tuesday thru Sunday for Exhibitors only, to prepare for the day's business. All Exhibit Spaces must be cleared and all displays removed by noon on Tuesday, April 21st, 2026. Opening and closing times of Indoor Exhibit hangers shall be enforced for Exhibitors' protection.

FEES: Exhibit Space fee includes the cost of a Polk County Occupational License and Exhibitor's credentials per Exhibit Space. Indoor displays include back drapes, side curtains and sign. Additional credentials may be purchased at the exhibit check-in or Main Registration building.

RESERVING EXHIBIT SPACE: SUN 'n FUN reserves the right to relocate Exhibitor to another Exhibit Space at any time and from time to time, either before or during the Expo. Full payment, received by September 15th, 2025, will guarantee an Exhibit Space as selected in the sole and exclusive discretion of SUN 'n FUN. Exhibitor understands and agrees that Exhibitor has no right to use or occupy any specific, fixed, or particular Exhibit Space and has not been granted exclusive use or occupancy of any such Exhibit Space. There is a 25% cancellation fee for each Exhibit Space cancelled. 50% cancellation fee thru February 28th, 2026. No refunds of payment will be made after February 28th 2026.

CLEANING & EARLY BREAKDOWN: All aisles will be maintained by SUN 'n FUN. All Exhibitors are required to clean their Exhibit Spaces at the close of each day. Breakdown and departure are not permitted before 2:00 p.m. on Sunday, April 19th, 2026. Exhibitor breaking down prior to 2:00 p.m. may be denied future Exhibit Space. Vehicle access is permitted at 6:00 p.m. on breakdown day. Any Exhibitor leaving bulk material, garbage, mulch and debris of any kind will have a post-show charge of \$250.00 for indoor Exhibit Space and \$500.00 for outdoor Exhibit Space.

NO SHIPMENTS TO SUN 'n FUN SITE: Shipments prior to the Expo shall only be made by contacting GES. SUN 'n FUN will not accept display or other material at the Expo site.

PERMITTED DISPLAYS: Indoor Exhibitors may install, at their own expense, special signs, displays, counters, shelving, and similar items not to exceed 10 feet in height from the floor along the rear of the Exhibit Space and along no more than 1/2 of the side dividers measured from the rear of the Exhibit Space. No materials may be hung from the hangar structure (e.g., no guide wires from hangar to rafters, no signs attached to walls). Shelving, signs, etc., extending above the side dividers must be approved in advance by SUN 'n FUN and have the back side thereof covered to the satisfaction of the Exhibit Chairman. Outdoor Exhibits shall not exceed 25 feet in height. Noisemakers, disruptive audio, amplifiers, flashing signs, microphones, portable air conditioners, and attention-getting devices are not allowed in any Exhibit Area. Portable air conditioners and generators prohibited inside.

VEHICLE ACCESS: During the Expo, vehicle access is permitted before 9:00 a.m. and after 5:00 p.m. Sunday, April 19th vehicle access at 6:00 p.m. **Vehicles will not be allowed to remain on or at Exhibit Space during the day. Any vehicle outside designated parking area will be towed at owner's expense.**

VEHICLE PARKING: Exhibitors will be issued a designated number of vehicle passes per Exhibit Space. A designated area will be provided for such Exhibitor parking, additional vehicle passes may be purchased. Any Exhibitor with Outdoor Exhibit Space may, with prior approval of SUN 'n FUN, park an R.V. on its Exhibit Space if it is essential to its exhibit in the sole and exclusive determination of SUN 'n FUN; however, it must remain parked on that Exhibit Space for the duration of the Expo. All trucks and trailers must park in the designated storage lot south end of the Pink Lot. **Passenger vehicles will not be allowed at or on Exhibit Space. Vehicles improperly parked will be towed at owner's expense.**

PETS: With the exception of service animals, no other animals of any kind are permitted in the Exhibit Areas.

CERTAIN VEHICLES PROHIBITED: The use of all-terrain vehicles (ATVs), bicycles, golf carts, mini-bikes, roller blades, scooters, and skateboards by Exhibitors at the Expo is strictly prohibited.

HANDICAPPED PARKING: Check with Handicapped Hospitality Center at Main Registration.

NATURE OF EXHIBITS: Only those products documented on this contract as approved by SUN 'n FUN shall be allowed to be sold or shown at Exhibitor's Exhibit Space. Food, drinks, coin-operated games, raffles, film, solicitations, charitable or otherwise, or sales of credit cards or phone cards, or items bearing off-color material, in the sole and exclusive determination of SUN 'n FUN, shall not be allowed.

LOGO USE: SUN 'n FUN does not authorize or grant a contract to any Exhibitors under this Agreement to use its name or trademarked logos or a derivative of, or confusingly similar logos, in any product, whether used for display, sale, or giveaways, without prior written permission of SUN 'n FUN. SUN 'n FUN reserves the right to confiscate any item that violates this provision.

ELECTRIC SERVICE: Each Exhibit Space designated for electric service has 20 amps/120 volts provided. Not to be used for Motor homes. Exhibit Space with 50 amps/240 volts are limited. No additional receptacles are available.

SUBLICENSING OF EXHIBIT SPACE—ASSIGNMENT OF LICENSE IS PROHIBITED: Exhibitors shall not sublicense any Exhibit Space in whole or part, nor display any goods other than those approved by SUN 'n FUN and manufactured or sold by Exhibitor in the regular course of business. In no event shall Exhibitor, Indoor or Outdoor, grant to any person or entity permission to share Exhibit Space or to occupy adjacent Exhibit Areas. Exhibitors shall not assign this contract. Any attempted sublicensing or assignment by Exhibitor shall automatically be null and void.

SOLICITATION OF BUSINESS – RESTRICTIONS: Solicitation will be confined to the Exhibit Areas and to those persons or firms who are bona fide Exhibitors by virtue of paying in full for Exhibit Space and being a party to this contract. Exhibitor shall not conduct business outside Exhibitor's assigned Exhibit Space. All Exhibitors participating in the SUN 'n FUN Aerospace Expo who engage in any form of sales or financial transactions are required to conduct such transactions under their own business or individual name. Exhibitors are strictly prohibited from using the SUN 'n FUN name, logo, or branding in any way that implies SUN 'n FUN is a party to, or responsible for, the transaction. SUN 'n FUN, Inc. does not authorize any Exhibitor to transact business on its behalf and assumes no liability for any goods or services sold by Exhibitors during the event. Failure to comply with this policy may result in removal from the event and/or exclusion from future participation.

PAID CAMPING: Exhibitors are ONLY permitted to camp where a 50-amp RV panel is available in their Exhibit Space (no water) for a fee. Primitive camping is available in Light Plane exhibit spaces as well as the SUN 'n FUN Campground for a fee. Tent camping and pop-up campers are prohibited on all Exhibit Spaces.

SECURITY: SUN 'n FUN will make every reasonable effort to have Security personnel on duty beginning 8 a.m. Tuesday, April 14th, 2026 through and including Sunday, April 19th, 2026.

SAFETY: No smoking, vaping, explosives, inflammables, or other dangerous items will be allowed in the Exhibit Areas. Decorations must be flame resistant. Those Exhibitors conducting demonstrations utilizing open flame, such as welding torches, must furnish appropriate safety equipment, including a fire extinguisher, and must have their demonstrations approved in advance by the SUN 'n FUN Safety and Exhibit Chairman. All Outdoor Exhibitors are required to have a 2A10BC fire extinguisher in their Exhibit Spaces. For safety reasons, all Outdoor Exhibitors using banners, flutter flags, or any signage that involves ground-installed spikes or brackets must remove or properly cover (e.g., with parking cones) all exposed spikes or brackets at the close of Exhibit Hours each day.

AIRCRAFT DISPLAYS: Display aircraft are expected to and shall remain at their Exhibit Spaces. Movement to and from the flight line is discouraged and limited to the following hours: 7:00 a.m. until 8:00 a.m. - 12:00 NOON until 1:00 p.m. - After the airshow until dusk. Only those aircraft having access to the taxiway without causing another display to be moved or dismantled may be taken out of an Exhibit Area. Please plan accordingly.

AIRCRAFT SAFETY: SUN 'n FUN requires that all aircraft in a Display or Commercial Exhibit Area disable the aircraft by (1) Removing the lead from the starter or (2) Disconnecting the battery or (3) Sparkplug leads must be disconnected. Aircraft must remain in that condition until ready to depart the Area.



SUN 'N FUN INSURANCE REQUIREMENTS



INSURANCE, LIABILITY, INDEMNITY RELEASE, AND HOLD HARMLESS: SUN 'n FUN shall not be liable or responsible for any claim, liability, loss, damage, or personal injury, including death, which may occur to the Exhibitor, to the Exhibitor's agents, representatives, servants, employees, customers, providers, suppliers, and/or guests, or to the Exhibitor's property from any cause whatsoever at any time including, specifically, the negligence of SUN 'n FUN and its employees, representatives, servants, or agents.

The Exhibitor hereby expressly releases SUN 'n FUN from and agrees to indemnify and hold SUN 'n FUN harmless from and against any and all claims, liability, loss, damage, or personal injury, including death and from and against property damage of any type or nature, including SUN 'n FUN's negligence.

Without limiting the foregoing, SUN 'n FUN shall not be responsible for the loss of any exhibit or part thereof because of fire or lightning, wind storm or hail, smoke, explosion, riot or civil commotion, vandalism or malicious mischief, burglary, robbery, hold-up, water damage, strike, or any accident involving damage to property or goods in transit, or for any personal injury, including death, that may occur to the Exhibitor, to the Exhibitor's agents, representatives, servants, employees, customers, providers, suppliers, and/or guests, or to the Exhibitor's property from any cause whatsoever at any time or for any exposure to any claims, liability, loss, damage, or personal injury including death.

SUN 'n Fun requires that the exhibitor obtain, at its expense, adequate insurance coverage prior to the expo to insure itself and to **name SUN 'n FUN Fly-In, Inc. and the City of Lakeland including it's respective officers, directors, employees, members, volunteers, affiliates, and divisions are included under the above referenced policy as Additional Insured against any claims, liability, loss, damage, or personal injury, including death, and property damage, whether during transit or while at or during the expo.**

PUBLIC LIABILITY: Each Exhibitor shall obtain and maintain public liability and employee compensation insurance policies which shall include coverage on and to the Exhibitor's property and on and to the Exhibitor's agents, representatives, servants, employees, providers, and/or suppliers while such property and such agents, representatives, servants, employees, providers, and/or suppliers are at, on, in, entering, or leaving the expo site.

In addition, the public liability insurance policy shall include coverage on and to the Exhibitor's agents, representatives, servants, employees, customers, providers, suppliers, and/or guests at, on, in, entering, or leaving the Exhibitor's exhibit space or exhibit area.

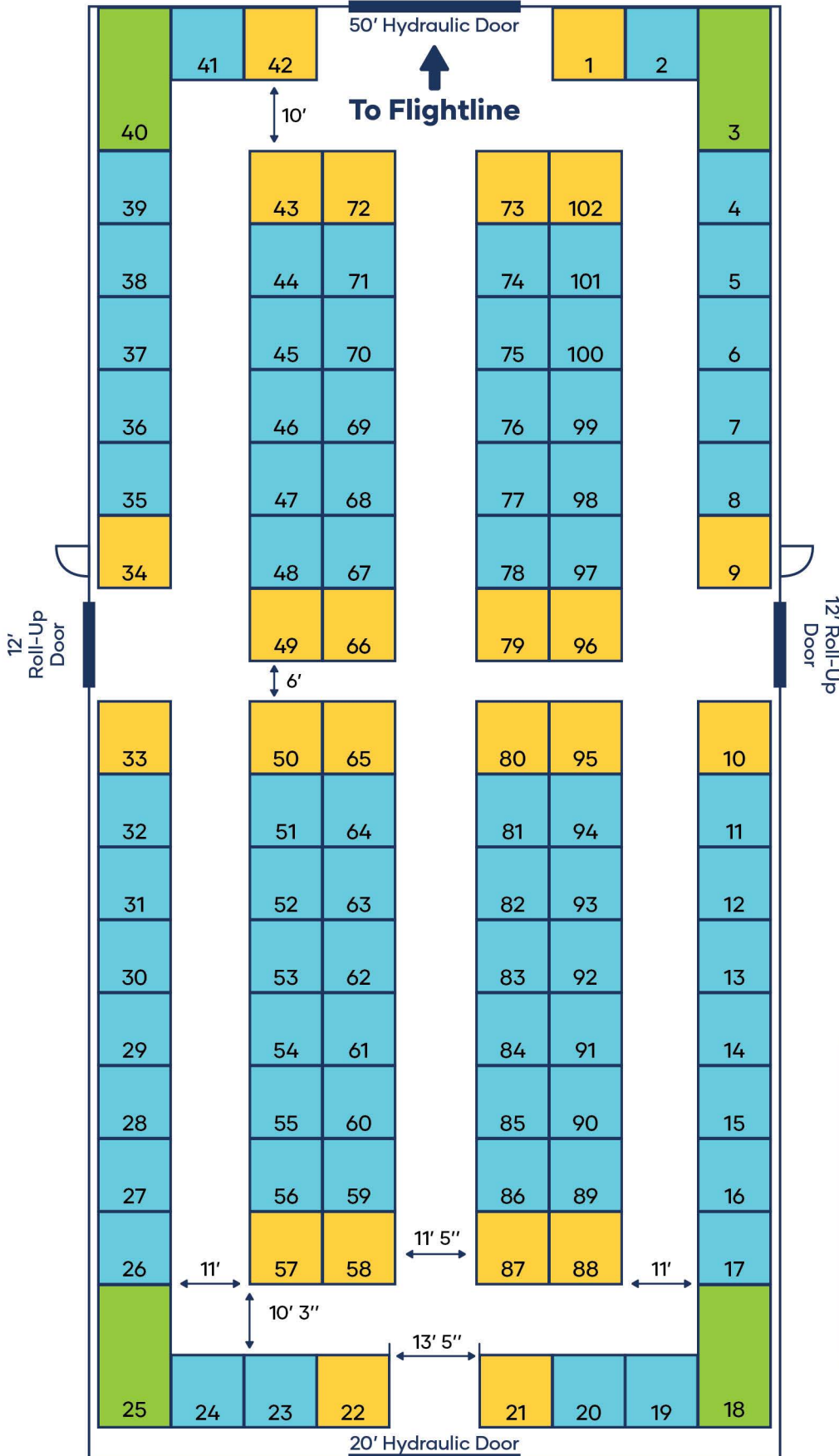
Exhibitors displaying aircraft are required to obtain and maintain valid aircraft hull and liability insurance coverage for the duration of their participation. Such coverage shall be designated as primary and non-contributory with respect to any insurance or self-insurance maintained by SUN 'n FUN Fly-In, Inc. and the City of Lakeland.

The policy **must name SUN 'n FUN Fly-In, Inc. and the City of Lakeland including it's respective officers, directors, employees, members, volunteers, affiliates, and divisions as Additional Insured** with respect to liability arising out of the Exhibitor's operations and participation at the event. Proof of such coverage must be provided to SUN 'n FUN prior to any aircraft being brought onto the premises, and SUN 'n FUN reserves the right to deny access or participation in the event if insurance documentation is not received or fails to meet these requirements.

The insurance policies required by this license shall include coverage for any personal injury including death and property damage and shall name **SUN 'n FUN Fly-In, Inc. and the City of Lakeland including it's respective officers, directors, employees, members, volunteers, affiliates, and divisions are included under the above referenced policy as Additional Insured.** minimum liability amount for any of such insurance policies shall be \$1,000,000.00.

INSURANCE CERTIFICATES: All certificates of insurance required hereunder shall be furnished to SUN 'n FUN **on or before March 1, 2026,** as a precondition to Exhibitor entering SUN 'n FUN's property including the expo site and the assigned exhibit space. Exhibitor's insurance policies shall be written on a **primary and non-contributory** basis, and shall not seek contribution from any insurance or self-insurance maintained by SUN 'n FUN. Each policy shall include a provision requiring the insurer to provide **no less than thirty (30) days' advance written notice** to SUN 'n FUN in the event of cancellation, non-renewal, or any material change in coverage. SUN 'n FUN reserves the right to deny access to the premises or revoke exhibit privileges if the required insurance documentation is not received or does not meet the stated requirements.

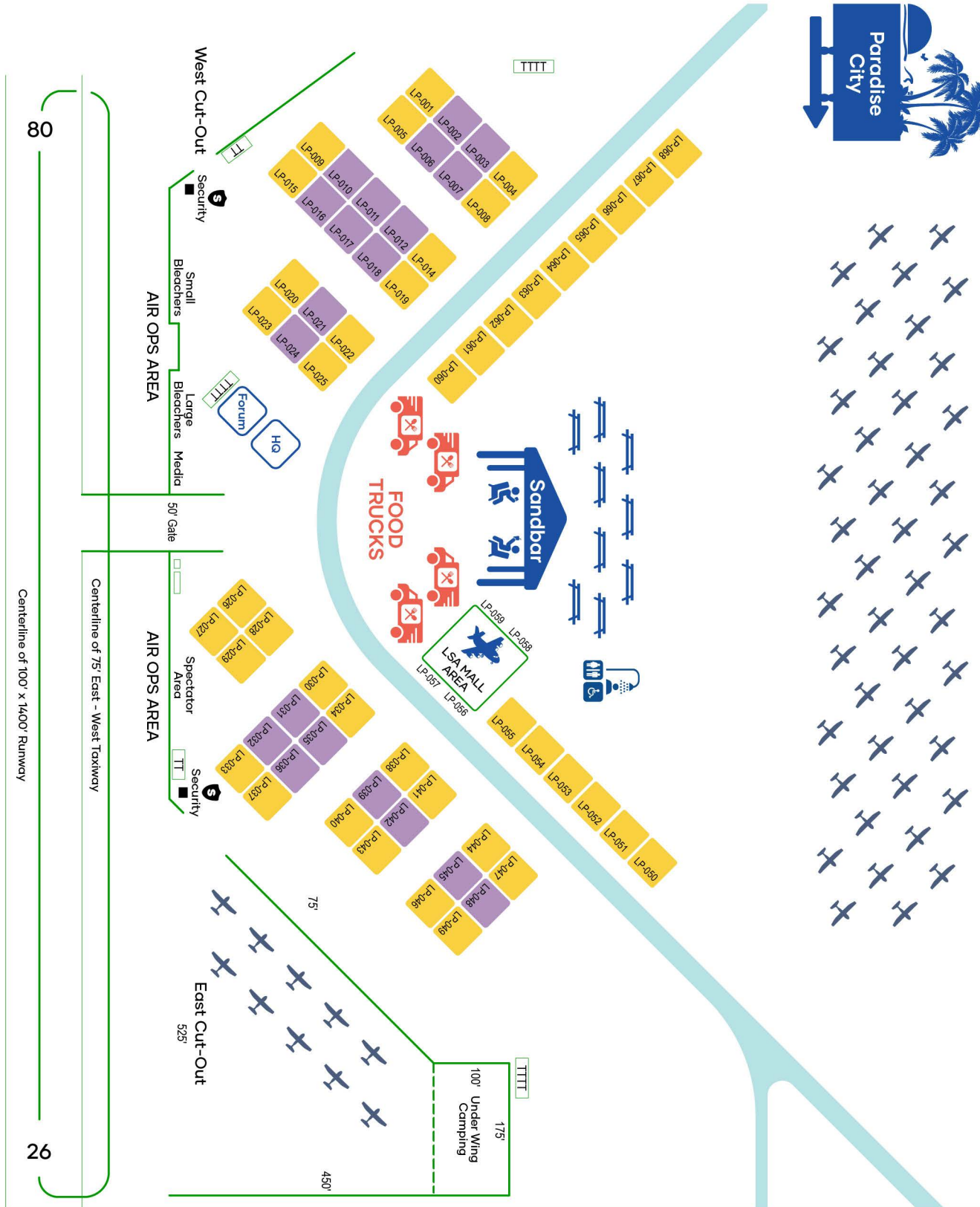

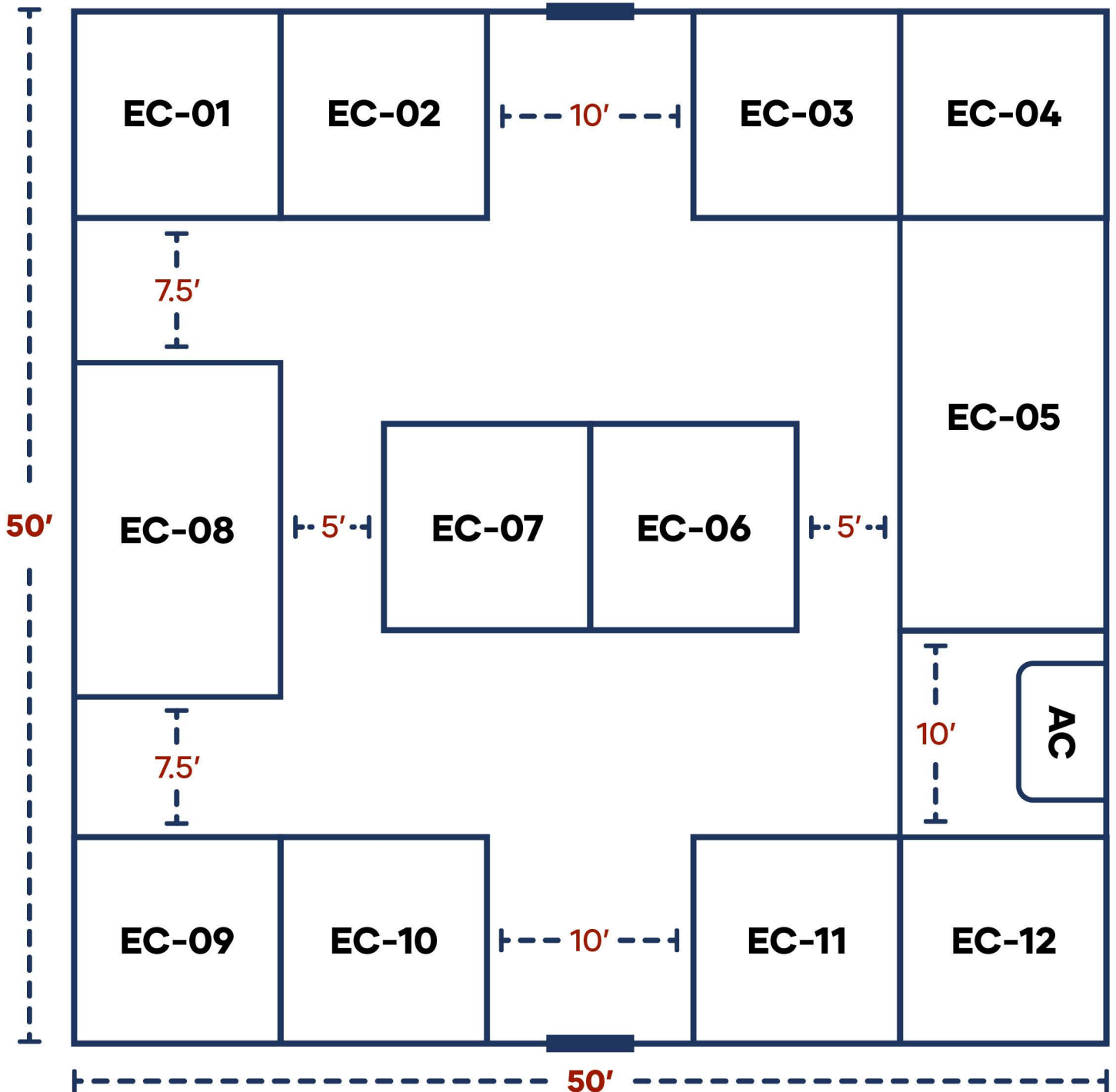

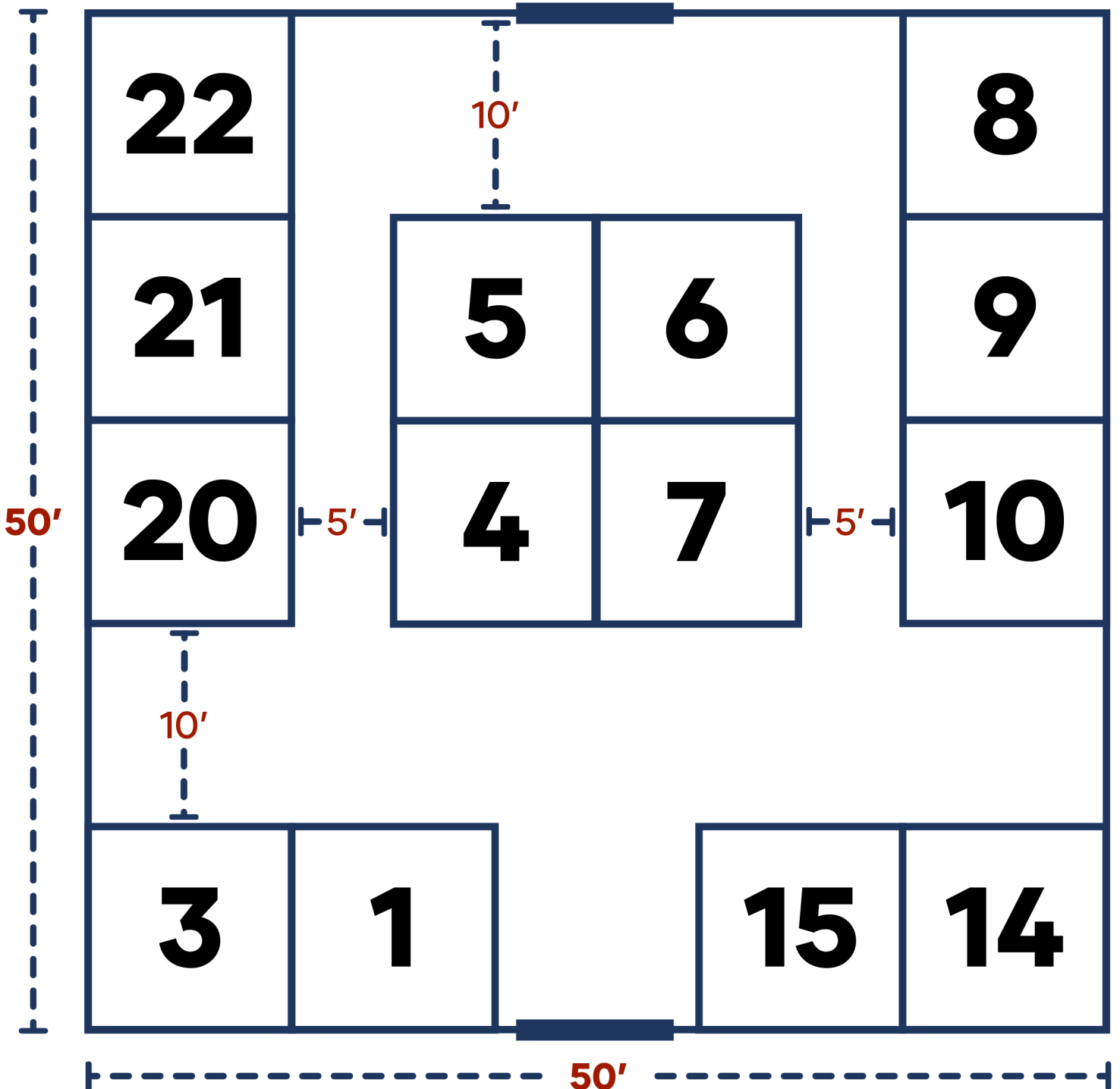
