

Media Waiver

As a condition of receiving media credentials for the Annual SUN 'n FUN Aerospace Expo, (herein after "Activity"), I (together with my custodial parent or guardian, if I am under the age of eighteen or under a legal disability) represent, covenant and agree, on behalf of myself and my heirs, assigns, and any other person claiming by, under or through me, as follows:

- 1. I understand and agree that SUN 'n FUN Fly-In, Inc. (SnF, Inc.) is the owner of all trademarks, copyrights and other proprietary rights connected to SnF, Inc. and retains all worldwide rights. Any broadcast, rebroadcast, or use of any accounts, pictures, or descriptions of events (with the exception of news broadcasts by legitimately accredited and credentialed news media) without the expressed written permission of SnF, Inc. is prohibited. All SnF, Inc. events, including the annual SUN 'n FUN Aerospace Expo are proprietary to SnF, Inc., and attendance or exhibition at the same is subject to SnF, Inc.'s policies and requirements, as well as all applicable laws.
